Guidelines for Submission of "SAHRS Distinguished Researcher Award" Nominations

Name of the Award:

The name of the award shall be "SAHRS Distinguished Researcher Award"

Objectives of the Award:

To recognize the faculty members who have shown dedication in their research programs. They should have exceptional creativity based on a track record of significant contribution to research, science and technology.

Validity:

A nomination is valid for one year only. In case candidate is not selected during the year, there is no provision for nomination to be carried forward for the next year, however re-nomination is permitted.

Criteria:

- 1. A faculty member is initially eligible after conducting independent research for a period of at least 10 years after obtaining their first academic appointment.
- 2. A faculty member may receive the Distinguished Researcher Award only once.
- 3. The applicant should be a member of SAHRS under any category.
- 4. The form should be duly forwarded by the concerning Head of the Department/Director of the Institute, if the nominee is working.
- 5. Significant contributions to research and scholarly activity as documented by research agencies, professional technical committees, government, community and not-for-profit organizations and/or professional, literary, and associations.
- 6. Sustained and significant direct contributions toward the training of highly qualified personnel (i.e., undergraduate, graduate, PDFs).
- 7. Claims should be as evidenced by published research papers, patents or any other publications demonstrating outstanding research work, inventions or discoveries in the respective fields.

Selection Procedure:

All the valid nominations, based on the subject area of the work, will be considered by the respective sectional committees of the society.

The minimum cut-off markers will be 70%. If the candidate is not achieved 70% mark, then his/her application will be automatically rejected. If single application is received and has score of 70% or more then it will be considered.

The award(s) need not be made each year should it be determined by members of the Selection Committee and/or the President that no suitable applications have been submitted.
